## Commitment to achieving Net Zero

Cutting Edge Surgical Instruments Ltd is committed to achieving Net Zero emissions by 2050.

## Baseline Emissions Footprint

Baseline emissions are a record of the greenhouse gases that have been produced in the past and were produced prior to the introduction of any strategies to reduce emissions. Baseline emissions are the reference point against which emissions reduction can be measured.

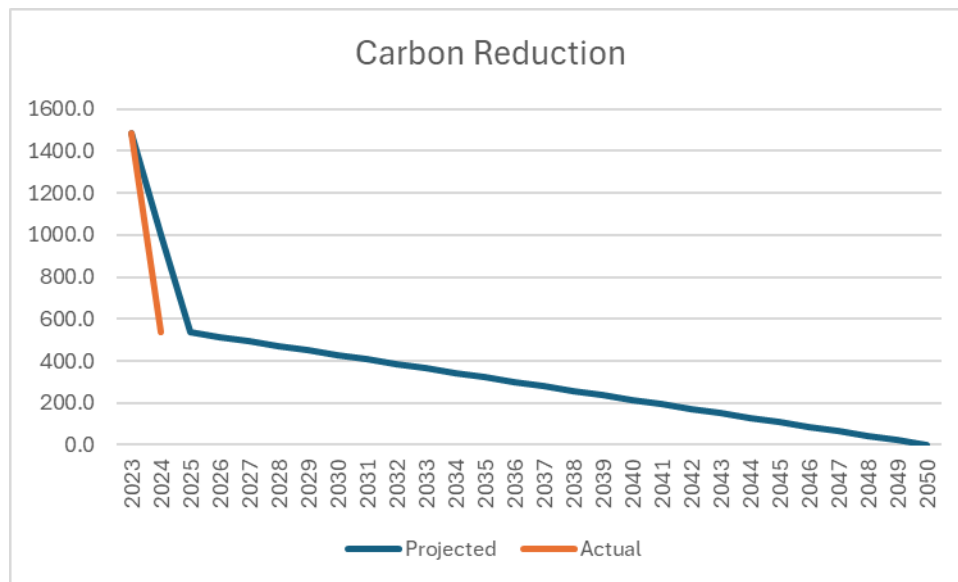

## Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We projected that carbon emissions will decrease over the next five years to 1121.21 tCO<sub>2</sub>e by 2028. This is a reduction of 24.57%. We have now revised this projection, given the improved reporting and calculating for scope 1, 2 and 3, to 472.5 tCO<sub>2</sub>e by 2028.

## Carbon Reduction Projects

### Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 1st April 2023 to 31st March 2024 baseline. The carbon emission reduction achieved by these schemes equate to 949.53 tCO<sub>2</sub>e, a 62.9% reduction against the 1st April 2023 to 31st March 2024 baseline and the measures will be in effect when performing the contract

## **Energy Efficiency**

- We have implemented a facility change to energy efficient LED Lighting with PIR lighting controls implemented in low foot fall areas to ensure lights are not left turned on where not required. Where PIR controls have not yet been implemented in low foot fall areas, additional signage has been put in place to encourage lights to be turned off.
- Thermostatically controlled eco efficient HVAC systems are used to negate the need for stand alone heaters and reduce the need to use gas boilers for heating.
- All staff are encouraged to “Turn-off” where possible at the end of their working days.
- Daily facility walk throughs are conducted at the end of each day to ensure all electrical items which can be turned off have been.

## **Waste Reduction and Eco Handling**

- We use Eco friendly commercial waste management services who commit to zero landfill and recycling as much as possible.

## **Company Fleet**

- The company fleet of vehicles is very small and over the last year 80% of our company fleet vehicles have been replaced with smaller engine eco models. This is beginning to show a reduction in the amount of petrol and diesel used, with greater mileage efficiency.

## **Electric Vehicle Charging Points**

- We provide access to 4 charging points at our facility.

In the future we hope to implement further measures such as:

## **Plastic Packaging Reduction**

- We aim to reduce the amount of plastic packaging used by working closely with our suppliers and our own internal processes to investigate and trial the use of more biodegradable and recyclable packaging materials.

## **Energy Supplies**

- We will investigate further increase of “green energy” from our energy suppliers, with the aim to achieve 100%.

## **Company Fleet**

- It is planned that future company fleet replacements or additions will move towards full electric vehicles once the availability, mileage capability and charging infrastructure improves.

## **Supply Chain Transportation**

- We will work with our suppliers to increase the size of shipments where possible to allow for fewer deliveries and therefore a reduction in the transportation emissions. We will also encourage our suppliers to investigate, and use where practical, more eco-friendly transportation options.

## Circular Economy

- We will continue to increase the support for circular economy by increasing the promotion of very high quality reusable Surgical Instruments alongside our repair service. This high quality approach will reduce wear and breakage whilst the repair service brings the majority of currently held instruments back to as intended use which then reduces the need for replacement with new and therefore reduces waste.

## Education and Awareness

We will increase employee awareness of energy saving and waste management measures and provide information emphasizing the desire to achieve, and importance of, carbon reduction.

## Declaration and Sign Off

This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.

Emissions have been reported and recorded in accordance with the published reporting standard for Carbon Reduction Plans and the GHG Reporting Protocol corporate standard<sup>1</sup> and uses the appropriate Government emission conversion factors for greenhouse gas company reporting<sup>2</sup>.

Scope 1 and Scope 2 emissions have been reported in accordance with SECR requirements, and the required subset of Scope 3 emissions have been reported in accordance with the published reporting standard for Carbon Reduction Plans and the Corporate Value Chain (Scope 3) Standard<sup>3</sup>.
